

# Applying for compensation and redress for child sexual abuse from prison



This fact sheet helps people currently in prison, and people convicted of serious criminal offences, understand their compensation options. **TasVOCAL** can provide free legal advice about compensation and redress options.

# Can I make a civil claim for compensation?

You may be able to file a civil claim for damages for injury and loss arising from the sexual abuse you suffered.

An experienced civil lawyer can provide legal advice about this. **TasVOCAL** can provide free legal advice and refer you to a civil lawyer. You should explore this option first.

# What is the National Redress Scheme (NRS)?

The NRS:

- acknowledges that many children were sexually abused in Australian institutions
- · holds institutions accountable for this abuse
- helps people who have experienced institutional child sexual abuse gain access to justice and redress.

If your application is accepted, the NRS can provide:

- a payment of up to \$150,000 depending on your experiences
- · counselling and other support services
- a direct personal response from the institution (e.g. an apology).

Applications can be made until 30 June 2027.

### Can I make a NRS application?

I have received a prison sentence of 5 years or more

If you have received a prison sentence of 5 years of more for a single criminal offence, you can still apply for redress.

The NRS will seek further information from the applicant and will be asked to fill out a 'Serious criminal convictions additional information form'.

### Assessing the additional information

There is a special assessment process for people with certain types of convictions. These include where a person has been sentenced to imprisonment for 5

years or longer and include unlawful killing, a sexual offence, a terrorism offence, or certain related offences.

If you have a serious criminal conviction that fits in the categories above the NRS will send information to you and **you should** seek advice.

A decision will then be made by the NRS about whether your application for redress can proceed.

#### **Financial Counselling**

If you receive a NRS payment there may be limitations in accessing the payment. Each prison and bank has different rules about accessing money. **TasVOCAL** can refer you to a financial counsellor who can speak to you about your individual situation before you accept a payment or civil compensation.
